

# TRANSFORMING THE BFSI SECTOR TO BOOST DEVELOPMENT OF LOCAL CONTENT AND INTEGRATION INTO MEGA PROJECTS

### **Context**

- b. Identify strategies for the BFSI sector to effectively support the country's economic and social development, in line with national growth and inclusion targets.

a. Establish a concrete action plan, with specific targets and initiatives, to ensure that the insights and discussions from the conference translate into effective actions and positive changes in the BFSI sector in Mozambique.

### **PANELS**

### Panel I
